- Never store cardholder data on a server connected to the Internet
- Facilitate secure remote access to application
- Encrypt sensitive data over

PA-DSS is an industry-specific data security standard related to application security issues involving credit card acceptance and processing. PA-DSS was derived from the Payment Card Industry (PCI) Data Security Standard, a unified standard between Visa, MasterCard, American Express, Discover and JCB card companies to address the growing issue of cardholder account security among US payment service providers and merchants. Secure payment applications, when implemented in a PA-DSS-compliant environment, minimize the potential for security breaches leading to compromises of full magnetic stripe data or CVV2, and the damaging fraud resulting from these breaches.
